 - I am aware of information on temporary limitations in functioning of NorthEast Marina Szczecin.

The person who signs the Mooring Declaration shall indicate the person/entity, on behalf of whom he or she makes the Mooring Agreement. In case when the person that signs the Declaration is not authorized to act on behalf of indicated person/entity or acts beyond given authorization, he or she shall be responsible for paying charges related to the vessel's parking and for any damages caused by the vessel or its crew.
