Berthing Provisions:

1. The method of using the berth and the Hirer's obligations are specified in the Szczecin Marina Regulations. The Hirer is obliged to comply with the Regulations.
2. The berthing fee is payable in advance in cash, by debit/credit card or by transfer to the bank account of the Marina Operator: Żegluga Szczecińska Turystyka Wydarzenia Sp. z o. o. – IBAN no: PL 60 1020 4795 0000 9402 0329 5961, BIC/SWIFT: BPKOPLPW, before the start of the berthing, but not later than 7 days from receiving the Berth Declaration, confirmed by the Marina employee, containing the payment for the declared period of berthing.
3. The berthing fee has been determined in accordance with the price list adopted by the resolution No. XLI/1179/18 of May 22, 2018 of the Szczecin City Council on determining the amount of fees for the lease of the Municipality of Szczecin quays and for the use of the port infrastructure of the quays of the Szczecin Marina on Grodzka Island.
4. The length of the watercraft in meters, rounded up to one decimal place, is adopted to calculate the fee.
5. In case of a change in the amount of the berthing fee resulting from a change in the resolution of the City Council of Szczecin on determining the amount of fees for the lease of the Municipality of Szczecin quays and for the use of the port infrastructure of the quays of the Szczecin Marina on Grodzka Island, the Marina Operator shall notify the Hirer of the new amount of the fee in writing. The new berthing fee applies from the first day of the month following the month in which the Hirer received the notification.
6. In the event of receiving the notification referred to in par. 5, the Hirer may terminate the agreement with a two-week notice period. The notice of termination may be submitted within 7 days from the date of receipt of the change in berthing fee notification.
7. During the events organized by the Municipality of Szczecin using the Szczecin Marina infrastructure, difficulties in accessing and functioning of the Szczecin Marina may occur. In connection with the mentioned events, it may also be necessary to re-moor vessels or leave the Marina, in accordance with par. 3 p. 5 of the Szczecin Marina Regulations.
8. In the event of a demand for the subject of the contract (events, renovation, etc.), the Hirer agrees to leave and hand over the berth within 7 days from the date of receiving such information from the Marina Operator. In this case, the berthing fee will be proportionately settled based on the period of use of the subject of the contract, and the Hirer will not be entitled to any compensation in this regard.
9. After the end of the declared berthing period, the Watercraft should be immediately removed from the berth. If the Watercraft is left, an additional fee will be charged in accordance with the Szczecin Marina Price List for each commenced day (24 hours) of berthing.
10. During the berthing the Marina Operator undertakes to enable the Hirer to collect water and electricity for a fee, through the power poles installed on the quays.
11. The Hirer is not allowed, without the prior written consent of the Marina Operator, to give up or sublease the berth or its part to a third party for use under no circumstances.
12. All correspondence between the parties will be sent to the addresses indicated in the Declaration. The parties undertake to notify each other in case of any change of an address. A letter sent to the other party by registered mail to the last known address, twice notified (advised), shall be deemed delivered.
13. After the end of berthing, the Hirer is obliged to return the subject of the lease in a condition not deteriorated beyond normal wear and tear.
